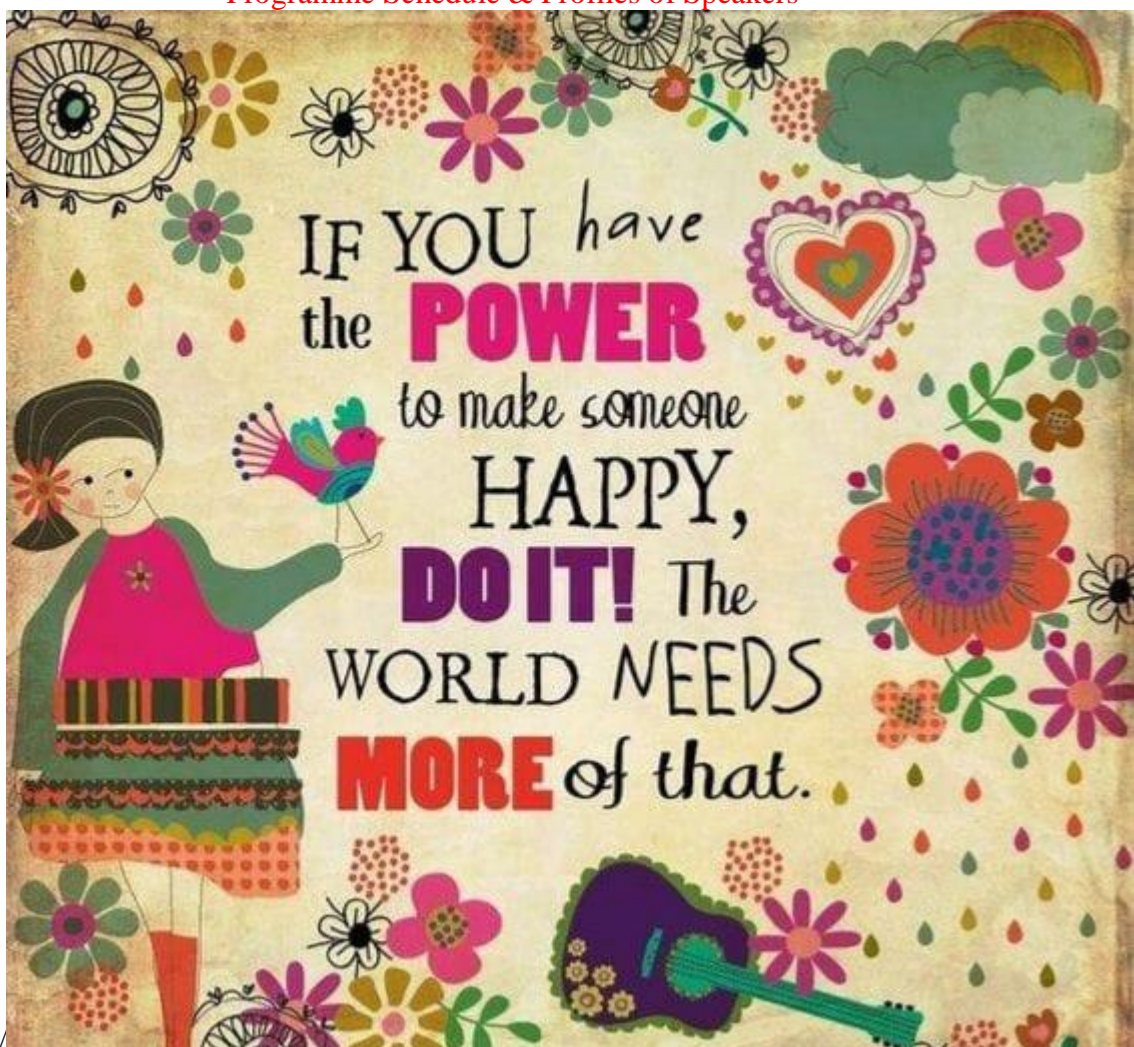

## **PROFILES OF SPEAKERS**



## Mr. Keshav Varma



Mr. Keshav Varma, had an exceptional and pioneering record of achievement as the Municipal Commissioner of Ahmedabad, India, a city of over six million, where he was credited with rejuvenating the organization with a much enhanced public image, high staff morale, and a well-defined strategic approach. During his tenure, Ahmedabad Municipal Corporation received an AA(SO) credit rating, and issued the “Ahmedabad City Bond”, the first municipal bond issued in South Asia without central or state government guarantees. Mr. Varma subsequently joined the World Bank as Sector Director of East Asia Urban Development and Disaster Management, a position he held until August, 2009, where he led the reconstruction and recovery work in Aceh, Sichuan and Myanmar in response to major natural disasters. He also led World Bank’s multi-billion dollar urban projects in China and cities of East Asia. Mr Varma is also part of important think tanks in urban policy and is well networked with important universities such as Harvard, MIT, Clemson, Duke where he teaches urban practice. He is also the Founding President of the International City Managers Association of India.

Based on his track record, entrepreneurship, and passion for balancing the needs of conservation and development, Mr. Varma conceived and mobilized a broad coalition of partners for the Global Tiger Initiative, and served as the Founding Director for Global Tiger Initiative (GTI), World Bank which quickly became a special program stimulating a partnership of 13 tiger range countries and international partners on the conservation of wild tigers. Mr. Varma’s main focus has been to change the conversation about conservation and introduce innovative ideas in the field of biodiversity and conservation. He has worked to create convergence and alignment among the strategies and needs of governments, business and communities through the development of Wildlife Business Councils (WBC) such as the Indian Wildlife Business Council. In 2013, Mr. Varma broadened the scope of GTI, to offer advisory services to the Government of the Kyrgyz Republic for an initiative for conservation and protection of the Snow Leopard launched by President of Kyrgyz Republic and involving 12 range countries. He has been appointed as the senior international advisor to the Global Snow Leopard and Ecosystems Protection (GSLEP) program ever since.

**He is now the CEO and Executive Director of the Global Tiger Initiative Council**, with Mr Robert Zoellick, former President of the World Bank and current Chairman of the Advisory Board of Goldman Sachs, as its Chairman. It covers 20 range countries and focuses on the conservation of tigers and snow leopards in the wild, with the Global Tiger forum (GTF) and GSLEP as its technical implementing arms. The council includes some of the most influential global leaders from business and industry, international financial institutions, international conservation agencies, academia and politics as its charter members.

**Mr. Varma is the advisor to the Government of Uttar Pradesh and Andhra Pradesh on the urban agenda, and the Chairman of the Sabarmati Riverfront Development Corporation.**

Mr. Keshav Varma belongs to the 1976 batch of the Indian Administrative Service (I.A.S.) - Gujarat Cadre.

**Dr. Amrita Dass**



Dr. Amrita Dass is a leading Educationist and Career-Consultant of the country. She is the Founder-Director of ICS-International (Established in 1985) and has the distinction of pioneering the career counselling and guidance services in India. She is also the Chairperson and Managing Director of ICS Education Ltd. ICS has conducted career counselling programmes in more than 200 schools, colleges, professional institutes and universities in India and abroad. It was recognised with **The Times Group “Award for Excellence in Education”** by the Hon’ble Governor of Uttar Pradesh, Shri Ram Naik.

Dr. Dass has had a meritorious academic background. She topped the Lucknow University and was awarded two gold medals. Thereafter, she pursued her doctoral studies at the University of Lucknow and London University as a fellow of the Indian Council of Historical Research (ICHR). She has participated in many international conferences such as the U.N. Social Summit-Denmark, U.N. Conference on Women - China, the State of the World Forum - U.S.A, Global Knowledge Partnership - Malaysia by the World Bank. She has visited universities the world over.

Dr. Dass is a consultant for a number of leading schools of the country and has served on the Boards of many prestigious Public Schools of India. She is currently a Board member of the renowned Avadh Girls' Post Graduate College, Lucknow, besides being on the Boards of Auckland House School, Shimla, Bishop Cotton School, Shimla and Nirmal Bhartia School, New Delhi. A multi faceted personality, she has been an Advisor to SIDBI, Member-Steering Committee on Women and Child Development, Planning Commission (9th Five Year Plan) and an Ex-officio Director of the State Bank of India. She has also designed and conducted numerous training programmes on Leadership for Edu-Leaders on Leadership in Education; on Excellence in Education for Teachers and on Leadership and Management for NGOs and Corporates. As a columnist for many prominent newspapers of the country, Dr. Dass writes on a wide range of educational, career and leadership issues. Known for her deep knowledge, insights, and futuristic vision, Dr. Dass has recently organized two conferences on Education and Careers bringing together all stake holders to make our students future ready. These were the first ever to be held in the world!

Her professional and philanthropic contribution has received many accolades. She is the recipient of the Lions Club Award for Outstanding Social Work; the Rotary Award for Vocational Excellence; TCS-Women Achiever of the Year Award and the Outstanding Women

Achiever Award by LMA. Her biography has been included in the Who's Who in the World 2015 (32nd Ed.) for exemplary contribution in the fields of Education and Career Guidance.

### **Hon. Mr. T.S. Powdyel**



Hon. Mr. Thakur S Powdyel is an educator by choice, conviction and passion. As the country's first democratically elected Minister of Education, he moved Bhutan towards fulfilling the MDGs and the country's constitutional mandate for education. His major interests include institutional integrity, national self-respect, moral literacy and gross national happiness. Powdyel was often referred to as the most foot-travelled education minister in the world.

Powdyel's vision of holistic education as expressed in *My Green School* has been translated into several languages. He is the author of *As I Am, So Is My Nation, Right of Vision & Occasional Views*, and principal author of *The Light of My Life*. His latest book *Gyal-Khab* is a reflection on State, citizen and citizenship education.

Powdyel is a recipient of the *International Gusi Peace Prize*, the *Global Education Award*, and the *Distinguished Service Award* for his pioneering work in Education as well as the *Coronation Gold Medal 2008* and the *Institutional Award: The Honour of Druk Thuksey 2012*.

Hon. Mr. Powdyel invested his public office with a rare and chastening quality of integrity, service and selflessness in the evolving Bhutanese democratic landscape in honour of his country and fellow-citizens, born of his deeply-held beliefs and convictions.

Professor Powdyel has been chair and member of several commissions and boards and is currently on the International Advisory Panel of the Malaysia-based Sejahtera Leadership Initiative.

### **Dr. H.R. Nagendra**



H. R. Nagendra, born on New Year's Day 1943 in the south Indian state of Karnataka, graduated in mechanical engineering and continued his studies to secure a doctoral degree (PhD) from the Indian Institute of Science (IISc), Bengaluru. He started his career by joining IISc as a member of faculty of mechanical engineering in 1968 and held the post till 1975. In between, he served as a post-doctoral fellow at the University of British Columbia in 1970 followed by a stint at Marshall Space Flight Center of NASA during 1970–71. During his stay in the US, he was

also associated with Harvard University as a consultant at their Engineering Sciences Laboratory from 1970 to 1972 after which he moved to London and worked as a visiting faculty at Imperial College of Science and Technology. Returning to India, he resumed his career at IISc which would stretch for two more years till he started his association in 1975 with Vivekananda Kendra, a spiritual organization founded in 1972 by Eknath Ranade, by taking up the post of the honorary director of the training centre at the organization's headquarters in Kanyakumari. For the next quarter of a century, Nagendra was involved with organizational and operational activities of Vivekananda Kendra. He became the national secretary of *Yoga Shiksha Vibhag*, the yoga education centre of the organization in 1975 and held the post till he was elected as the national vice president of the organization in 1993. In between, he also held the post of the Secretary of *Vivekananda Kendra Yoga Therapy and Research Committee* from 1979 to 1986 and the post of the Secretary of Vivekananda Kendra Yoga Research Foundation and the Director of Indian Yoga Institute from 1986 to 2000. In 2000, he became the president of Vivekananda Yoga Anusandhana Samsthana, which was started as a society in 2000, and when the society started its academic programs in 2002, he became its founder vice chancellor. The university was subsequently recognized by the University Grants Commission as a deemed university. He served as the vice chancellor of the university till 2013 when Ramachandra G. Bhat took over the position but continues his association with the university as its chancellor. He has also served as a member of the *working group on health* of the erstwhile Planning Commission of India.

### **Mr. AlokRanjan**



Mr. Alok Ranjan is a retired 1978 batch IAS officer from the U.P Cadre. He retired on 1 July 2016 after holding the office of Chief Secretary for the Government of Uttar Pradesh (the highest ranking Civil Service official in the State Government of Uttar Pradesh) for over two years. Prior to this he has held various portfolios including Infrastructure and Industrial Development Commissioner (IIDC) and Agriculture Production Commissioner (APC) for the state of Uttar Pradesh.

After retirement, he was appointed as the Chief Adviser to Chief Minister of U.P and Chairman U.P.S.I.D.C (Uttar Pradesh State Industrial Development Corporation). He resigned from this post following the defeat of the incumbent Samajwadi Party government in the state assembly elections.

An established thought leader and public speaker he has given talks at various educational and business forums such as CII (Confederation of Indian Industry), PHD Chamber of Commerce and Industry, IIM's etc. He is an author of two books, and also writes articles for leading national publications such as Times of India, Economic Times, Business Standard, HT and more.

Alok Ranjan's wife, Surabhi Ranjan is a professional singer and social worker. She was honoured with Yash Bharti award by the state government for her exemplary contribution in the fields of art, culture, cinema and sports.

## **Mr. A.K. Mathur**



Mr. Arun Kumar Mathur currently Sr. Vice President Lucknow Management Association is a power sector professional. He has been an Advisor to Crisil Infrastructure Advisory, Indian Institute of Management Lucknow and Mercer Human Resource Consulting.

Mr. Mathur is a former Chief Engineer and Director General (Power Purchase Agreements) of erstwhile U.P. State Electricity Board responsible for facilitating private sector investments in power projects in Uttar Pradesh. In this role he was responsible for power purchase agreements & escrow capacity finalization, representing U.P. in High Powered Crisis Resolution Group on IPP projects headed by Union Power Minister, formulating environmental and social policies for transmission projects and policy formulation in various areas preceding re-structuring of power sector in Uttar Pradesh. Earlier, he held the positions of Chief Engineer/ General Manager (Civil), President Electricity Service Commission, Superintending Engineer, Dy. Director, Staff College and other positions responsible for execution of civil works in thermal power stations, transmission and distribution projects of UPSEB.

After restructuring of power sector in U.P. he worked as Chief General Manager and then Executive Director in U.P. Rajya Vidyut Utpadan Nigam Ltd., responsible for thermal generation in the state of Uttar Pradesh. Authored several papers to bring clarity in the generation tariff structure, initiate reforms in UPRVUNL and facilitate PPA between UPPCL & UPRVUNL. Bachelor in Civil Engineering from Aligarh Muslim University, Mr. Mathur has authored many technical papers and reports; two of his papers were accepted for presentation in International conferences. He has attended and organized several major conferences on technical and management subjects.

Mr. Mathur has been actively associated with Lucknow Management Association since August, 2001 and has held various elected posts in the Association including its full time Executive Director till recently and is currently its Sr. Vice President. During this period, LMA rose from AIMA category 4 to category 1 management association, winning AIMA best local management association award in various categories for seven years LMA's assets rose almost hundred folds since 2002. Mr. Mathur's significant contribution in growth of LMA is widely recognized. Mr. Mathur has been nominated as Director of LMA Annual Conventions since 2005.

## Professor Geshe Ngawang Samten



Born on July 7, 1956 at Dokhar in Central Tibet, Professor Samten came to India along with his parents after the Chinese occupation of Tibet in 1959. He studied at the Central School for Tibetans in Chandragiri, Orissa, and thereafter at the Central Institute of Higher Tibetan Studies at Sarnath, where he earned the titles of Shastri, Acharya and M.Phil. He possesses a rare combination of the schooling on modern lines as well as the Tibetan monastic education system. He had his monastic education at Gaden Shartse Monastery at Mundgod in Karnataka. He obtained Geshe Dhorampa and later Geshe Lharampa degree, equivalent to Ph.D. degree in the modern system.

He began his academic career in the Research Department, and became Head of the Research Department devoted to the restoration of the lost Buddhist texts into Sanskrit, based on the classical Tibetan translations made in ancient times jointly by the Indian and Tibetan Pundits. This unique research activity evinces his erudition both in the classical Tibetan and Sanskrit languages as well as the rare translation skills. As a result of his outstanding achievement in his field, he was promoted to the position of Professor of Buddhist Philosophy. He is also actively engaged in Hindi translations of Buddhist texts in Sanskrit and Tibetan. Professor Samten, with his special interest in the philosophy of Nagarjuna, published the definitive critical edition of the *Ratnavali* with its commentary as the result of his post-graduate research. He is credited with important publications, such as a critical edition of *Abhidhammattha Samgaho*, a critical edition of Sanskrit and Tibetan versions of the *Pindidrita* and the *Pancakrama* of Nagarjuna, and co-authored *The Ocean of Reasoning*, an annotated English translation of the commentary on Nagarjuna's *Mulamadhyamaka Karika* by the Tibetan master thinker Tson-Kha-Pa, published by Oxford University Press. *The Ocean of Reasoning* is acclaimed far and wide.

He has made substantial contribution to the improvement of academic standards at CUTS, particularly through teaching and research. He is instrumental in promoting Buddhist Studies in India. A number of Indian universities have greatly been benefited by his scholarship and insight in formulating courses in Buddhist studies. He strongly advocates to make the education system instrumental in transforming the students through inculcation of value along with development of skills in various fields.

He frequently travels across the continents lecturing to academic audiences in the United States, Europe, Australia, Russia, some of the Asian countries and as well in India. He has been in action at various national and international seminars, workshops and conferences. He has held Visiting

Professorial assignments at Hampshire, Amherst and Smith Colleges in the USA and at the University of Tasmania in Australia.

In virtue of his sagacity and wisdom, Professor Samten has been on numerous academic bodies of Universities and expert committees of the Ministries of Government of India, and as a member on the boards of several Institutes in USA, Canada, Thailand, France and Austria. He has also served in the Editorial Board of International Association of Tibetan Studies in Harvard. He has been the Vice President of Association of Indian Universities, and has served chairman/member of various expert committees constituted by the University Grant Commission of India.

In 2009, he has been awarded *Padma Shri* (one of the country's highest civilian awards) by the President of India for his distinguished services in the field of education and literature.

In 2016, he has been awarded *Vesak Samman* by the Government of India in recognition of his outstanding contribution to the preservation, development and promotion of Indian philosophy, arts and culture within and outside India, as well as his lifelong services towards dissemination of Buddhist studies and establishment of academic institutions.

He is currently the Vice-Chancellor of Central Institute of Higher Tibetan Studies (Deemed University), Sarnath, Varanasi.

### **Dr. Aya Okada**



**Dr. Aya Okada** is Vice Trustee for International Cooperation and Professor of Political Economy at the Graduate School of International Development (GSID), Nagoya University. She holds an M.Phil. in Development Studies from the University of Sussex and a Ph.D. in Economic Development from Massachusetts Institute of Technology (MIT). Her research interests include economic and social development, regional planning, education and skills development, and gender and development.

Her publications include books such as *Industrial Skills Development: Globalization and Human Resource Development in Developing Countries* (co-edited, 2008, in Japanese), numerous book chapters, and articles in international journals such as *World Development*. Dr. Okada was Research Fellow at MIT's Industrial Performance Center (IPC) in 1997–1998. More recently, she was a visiting scholar at MIT and visiting professor at Jawaharlal Nehru University in India, both as an Abe Fellow awarded by the Social Science Research Council. More recently, she has also played consulting/advisory roles in development projects sponsored by JICA, UNESCO, and the Japanese government.

### **Dr. Bharat Bhaskar**

An MBBS graduate from JIPMER Pondicherry in 1978, Dr. Choudhuri obtained the MD (Medicine) & DM (Gastroenterology) degrees from the All India Institute of Medical Sciences, New Delhi, in 1982 and 1984 respectively. He is a distinguished Fellow of many prestigious bodies, including the American College of Gastroenterology (FACG), the Indian College of Physicians (FICP), the Academy of Medical Sciences (FAMS), and the Royal College of Physicians of Ireland (FRCPI). Over the years, Dr. Choudhuri has been widely recognised in his field and is the recipient of several awards acknowledging his contribution.

Dr. Gourdas Choudhuri served as a faculty member for 25 years at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow. During his tenure as Professor & Head of Gastroenterology for 10 years, the department was ranked among the top five in the country. Just prior to his current assignment with Fortis, Dr. Choudhuri was Vice Chairman, Institute of Digestive & Hepatobiliary Sciences, at Medanta, The Medicity, Gurgaon.

Dr. Choudhuri has pioneered many initiatives in the treatment of hepatobiliary and pancreatic diseases in the country. Dr. Choudhuri has served as Council member of international bodies such as the World Gastroenterology Organization (WGO), Asia Pacific Association of Gastroenterology (APAGE) and Coalition for Eradication of Viral Hepatitis from Asia Pacific (CEVHAP). He has also been a Fellow of the World Health Organization (WHO) for Health Promotion.

## **Dr. Vishwajeet Kumar**



Dr. Vishwajeet Kumar is Founder and CEO of Community Empowerment Lab – a community embedded global co-laboratory based out of Shivgarh, Uttar Pradesh. The Lab provides an enriching environment for multidisciplinary community-based research for developing new human-centric approaches, methodologies, and products to address maternal, newborn as well as child healthcare and neurodevelopment needs.

Dr. Vishwajeet Kumar is currently leading an implementation science study to universalize Kangaroo Care, in Uttar Pradesh through the health care facilities with the objective of designing a blueprint for scale throughout the Indian health system. He recently also completed a large scale experiment along with Ariadne Labs, Boston, to investigate a coaching-based WHO Safe Childbirth Checklist Program that was conducted in 60 pairs of primary care facilities across 24 districts of Uttar Pradesh, which led to an increase in adherence to essential care practices among birth attendants.

He serves on several technical advisory boards of global, governmental, and professional bodies including the Global Alliance for Vaccine Initiative and the Technical Advisory Group on Kangaroo Mother Care for Government of India. He has received multiple Grand Challenges Awards, was a Rockefeller Bellagio Resident, and has published widely in leading global scientific journals. He is also a featured speaker at ChildX Symposium Stanford and TEDx Delhi. He mentors young public health professionals and serves as guest faculty at leading academic and policy institutions. Dr. Vishwajeet Kumar is an alumnus and former faculty of Johns Hopkins University Baltimore USA.

## **Dr. Rajesh Gopal**



Dr. Rajesh Gopal has been closely associated with ‘Project Tiger’ in India for almost 35 years. As a former member of the Indian Forest Service, he was the Director of several tiger rich reserves in Central India like Kanha and Bandhavgarh for over a decade, while taking many initiatives to protect the tiger, its habitat and prey. He implemented special innovative in-situ actions to conserve the endangered Central Indian swamp deer as well. As a zoologist with a doctorate on the ‘*Barasingha*’ (swampdeer), Rajesh Gopal brought experience in the science of field management, while restructuring the management plan of Kanha.

His subsequent long stint working for the Government of India as the national coordinator of Project Tiger resulted in many milestone initiatives on the tiger front, including switching to the double sampling method using camera traps for country level tiger assessment; inclusion of a separate set of legal provisions for tiger conservation in India's national legislation; revision of the Project Tiger scheme with enhanced resource allocation; increase in Project Tiger coverage from 25 reserves in 2001 to 47 in 2015; and creation of National Tiger Conservation Authority, Wildlife Crime Control Bureau. Additional initiatives included year round tiger monitoring, e-surveillance, creation of a tiger photo database national repository, deploying special operators in the field, institutionalising smart patrolling, tiger translocation to low density habitats, and supporting research projects in collaboration with the Wildlife Institute of India.

Such concerted efforts have brought in a paradigm shift in tiger conservation, with a strengthened exclusive 'tiger agenda' in core areas, complemented by an equally aggressive 'inclusive' co-occurrence agenda in buffers and corridors to address the human-tiger interface. Rajesh Gopal has authored three books and a number of research papers and has received several awards including the JN Fellowship. Rajesh is now the Secretary General of the Global Tiger Forum, engaged with tiger range countries and partners to strengthen tiger conservation globally.

### **Professor Abbas Ali Mahdi**



Professor Abbas Ali Mahdi was Vice Chancellor, Era University, Lucknow till recently and has returned to his substantive position as Professor and Head Department of Biochemistry at King George's Medical University, Lucknow (India).
