### **Foreword**

Most organizations, both in public and private sector, engage contract labour to achieve efficiency and cost effectiveness in some jobs. Turnkey contracts, franchise and outsourcing are also extensions of contract labour systems. Managers, therefore, not only need to know the Act regulating Contract Labour but also its nuances to be able to manage the litigation involving Contract labour.

Number of Cases relating to service matters going to courts, especially in Government, is huge and all managers need to understand the rules and procedures relating to service matters as also the view taken by courts so that not only the personnel issues are managed better but organizations improve their success rate in related litigation.

Labour Laws are seen to be complex, sometime inconsistent, confusing and too many. The confusion is further compounded by a plethora of court judgments, at times at variance from one another. Managers, therefore, have to keep abreast with not only the essentials of the law but its fast changing interpretation. While help of Advocates and labour law experts has to be obtained for contesting complex cases in the courts, some degree of proficiency is necessary in managers to handle day to day situations on their own.

AIMA had conceived a three day programme to sensitize the managers dealing with these issues which LMA had been successfully organizing at Lucknow. We suitably updated the programme material in every course which was published in two volumes, one covering the management of contract labour and the other latest in labour laws, for use in these programme. Later, we added cases related to service matters which have been the subject of largest numbers of court cases.

In the present material compiled only in one volume is for use in the programme scheduled on 21 and 22 November 2015. Effort has been made to use only the latest Supreme Court cases on different issues deleting older cases.
